- 1. Applications are invited till 5.00 pm of 23-12-2013 (Monday) from the citizens of India as defined under Article 5 and 6 of the Constitution of India for filling up 5 (Five) vacant posts of Barkandaz (Driver) in the Principal Seat of Gauhati High Court at Guwahati in the scale of pay of Rs. 5200 20200 with Grade Pay Rs. 2100 (PB-2) plus other allowances as admissible under the Rules. The number of post advertised may vary on either side i.e. increase or decrease at the time of final selection.
- 2. The candidate should have a minimum educational qualification of Class VIII Standard and should possess a valid **Professional Driving Licence**. The candidate should not be more than 38 years of age and less than 18 years of age as on the last date of submission of application. The upper age limit will be relaxed up to 5 (five) years in case of candidates belonging to SC/ST.
- 3. The scheme of selection process and other details will be notified in due course of time in the official website of Gauhati High Court (www.ghconline.gov.in).
- Reservation for the candidates belonging to different categories will be as per the Gauhati High Court Rules.
- 5. The Pension and other retirement benefits will be governed by "the new defined Contributory Pension Scheme" of the Govt. of Assam.

#### 6. How to apply:

- a) Candidates are first required to go to the website <a href="www.ghconline.gov.in">www.ghconline.gov.in</a>, download and take printout of the "Fee Payment Challan" and the "Application Form" available along with this advertisement.
- b) Fill in the "Fee Payment Challan" in a clear and legible handwriting in BLOCK LETTERS.
- c) Go to the nearest State Bank of India Branch with the "Fee Payment Challan" and pay, in cash, the appropriate Application Fee into **SBI Powerjyoti Account No. 32512284007**. The fee once paid will not be refunded in any case. Bank transaction charges will have to be borne by the candidates.

- d) Candidates should obtain the Candidate's Copy of the "Fee Payment Challan", duly authenticated by the Bank with (a) Branch Name & Code No, (b) Transaction id/Journal number (c) Date of Deposit & amount, filled in by the Branch Official.
- e) In case candidate fails to deposit the fee, and fails to submit the copy of the "Fee Payment Challan" along with the application form, his/her application shall be cancelled / rejected without further communication and shall not be considered for further processing.
- f) Candidates shall, thereafter fill the Application Form and paste his/her recent passport sized coloured photograph in the given space of the application form and shall sign across the photograph. Four copies of the same photograph should be stapled in the top right corner of the application form and the candidate should write his/her name on the reverse of the stapled photographs. The envelope containing the application form should be super scribed as "APPLICATION FOR THE POST OF BARKANDAZ (DRIVER)" and the same should be addressed to "The Registrar (Admin.) —cum In Charge Recruitment Cell, Gauhati High Court, Guwahati, Assam."
- g) The envelope containing the application form along with other relevant documents should be dropped in the DROP BOX labeled "DROP BOX OF APPLICATIONS FOR THE POST OF BARKANDAZ (DRIVER)" kept within the High Court premises.

- h) Applications submitted in any other mode, except as indicated, will be summarily rejected without any communication.
- i) There is no need of submitting photocopy of any document at this stage, except the following, along with the application:
  - (1) The Candidate's copy of the "Fee Payment Challan" in original. A photocopy of the same should be kept by the candidate for his/her own record.
  - (2) Passport photos as indicated in sub-clause (f) above.
  - (3) A self-attested photocopy of the professional driving licence.
- j) Candidates who are already in Govt. Service will have to submit "No Objection Certificate" from proper authority at the time of viva-voce and checking of original document, if shortlisted for viva-voce.
- k) The list of the candidates, with allotted Roll Nos. will be published on high court website for reference of the candidates after closure of Advertisement.
- 7. The Gauhati High Court reserves the right to alter/modify or change any of the terms and conditions including selection criteria etc. spelt out in the advertisement.
- 8. The certificate for claim of reservation must be issued by the competent authority.
- 9. No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the service.
- 10. The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before or after the selection test, it is found that a candidate does not fulfill any of the eligibility condition, his candidature shall stand cancelled without any notice.
