In the event of his/her final selection, the candidates who are presently employed in Central or State Government services, will be required to produce a 'No Objection Certificate' (NOC) from the present employer.


Calling of the aforementioned candidates to the Interview/Viva-Voce is purely provisional and does not mean acceptance of their candidatures, which shall be further
