Pursuant to the advertisement dated 08/02/2018, the Gauhati High Court has been pleased to notify the Selection Process as well as the Schedule of the Examinations for direct recruitment to 1 (one) post of System Analyst, 6(Six) post of Judicial Assistant, 1 (one) post of Electrician and 1 (one) post of Chef (Cook) for the Itanagar Permanent Bench of Arunachal Pradesh.

### **Selection Process for System Analyst:**

The Selection test will consist of a written examination (Objective type/ Multiple Choices) of one paper (100 marks) conducted on OMR answer scripts, practical examination (30 marks) and vivavoce (30 marks).

Thereafter the candidates equal to 5 times of the number of vacancies (1:5), in order of merit in the written examination, will be called for the Practical Examination and then the candidates equal to 3 (three) times of the number of vacancies (1:3), in order of merit in the practical examination, will be called for viva-voce and checking of Original Testimonials. On the basis of marks obtained in written test, practical examination and viva-voce the final panel will be prepared. However, final selection shall be subject to overall suitability to be decided by the Gauhati High Court.

There will be no negative marking for wrong answer. The cut of marks shall be as decided by the Gauhati High Court.
