

**THE GAUHATI HIGH COURT AT GUWAHATI**

**ORDER**

HC.VII-238/2013/ 3727 /A

Dated Guwahati the 11<sup>th</sup> June, 2014.

**Shri Hrishikesh Goswami** is temporarily appointed on contractual basis in the post of **Court Manager**, District Court at Hailakandi created vide Notification No.JDJ.124/2011.21 dated 21.07.2012 issued by the Govt. of Assam at a consolidated pay of ₹ 50,000/- (Rupees Fifty thousand only) per month, with effect from the date of his joining. Appointment of the candidate is purely temporary and he may be terminated at any time without assigning any reason whatsoever.

**Shri Hrishikesh Goswami is directed to join his place of posting immediately and submit his joining report to the undersigned through the District & Sessions Judge, Hailakandi.**

The service of the aforementioned candidate shall be governed by the Gauhati High Court (Appointment and Conditions of Service of Court Managers) (Assam) Rules 2012.

The expenditure is debitable to the Head of Account "2014-Admin. of Justice. 105 - Civil & Sessions Court-6341 - 13<sup>th</sup> Finance Commission -26- Other Charge General Non Plan (voted)" in the current year's Budget for 2012-2013.
