Written Examinations (Objective Type Questions with Multiple Choices) on OMR (Optical Mark Recognition) answer scripts for recruitment of 2(two) Library Assistants & 2(two) Computer Operators (Regular) for the Principal Seat of the Gauhati High Court will be held in Guwahati on 9th December, 2012(Sunday) from 9:00 am to 11.00 am (for Library Assistants) & from 12.00 pm to 2.00 pm (for Computer Operators). Duration of both the examinations will be 2(two) hours. The selection procedure for posts of Library Assistant shall be as provided in the advertisement dated 11-01-2012.

The selection procedure for Computer Operator (Regular) shall consist of a written test on the basis of 150 marks in OMR answer scripts. The general candidates securing 60% marks and the reserved category candidates securing 55% marks in the written test would be called for a skill test. The skill test would be conducted for 50 marks. The candidates, both general and reserved categories, securing at least 30 marks out of 50 marks in the skill test would be called for interview, which shall be for 25 marks.

It is further notified that the candidates, whose applications have been found complete on preliminary scrutiny by the Registry, are being called for the Examinations as mentioned above, except those candidates whose applications were found incomplete on preliminary scrutiny. Please note that candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement. No T.A/D.A will be paid to the candidates.

All the candidates will have to download and take Printout of their Admit Cards from the Official Website of Gauhati High Court (www.ghconline.gov.in) between 10.00 am of 1st December, 2012 to 4:00 pm of 8th December, 2012. The candidates shall bring to the Examination Hall the Admit Cards with duly pasted passport size photograph thereon, while appearing in the Examinations. If any candidate fails to download the "Admit Card" from the website, he/she may contact in person the Recruitment Cell of the Gauhati High Court in Guwahati on 06-12-2012 & 07-12-2012 during office hours.
