The test of typing speed and accuracy in word processing shall be conducted with the help of a typing application software. Candidates will be required to type for 5 (five) minutes and on the basis of such typing, the number of correct words per minute (WPM)/net speed of the

candidate will be taken into consideration. 1(one) mark will be awarded for every word typed correctly which would be the net speed on the basis of such typing. The software to be used for the typing test may, to some extent, be akin to a typing test available in www.10fastfingers.com or www.typingtest.com. The Gauhati High Court reserves the right to fix cut off marks in the typing test.

Candidates are directed to bring all testimonials, acknowledgement slip of online application, admit card of Common Written Examination (Morning Session), two recent passport sized coloured photographs, work experience certificate, if any, etc., in original, along with a set of self-attested photocopies. The self-attested copies shall be handed over to the Joint Registrar (Recruitment) at the time of the computer typing test.

In the event of his/her final selection, the candidates who are presently employed in Central or State Government services, will be required to produce a No Objection Certificate (NOC) from the present employer.

Calling of the aforementioned candidates to the computer typing test is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate at any time. The candidature of the candidates shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 6-8-2015. No TA/DA will be paid to the candidates.
