No. HC.V- 55/2014/ 314 / Estt. # # # Sri Alakesh Sarma & Sri Bijan Hazarika are temporarily appointed as Judicial Assistants in the Principal Seat of the Gauhati High Court, Guwahati vice Sri Sourav Mondol, who was released from the High Court Service and Sri Anil Kumar Singha, who is promoted as Senior Judicial Assistant respectively in the usual scale of pay of Rs. 5,200-20,200/-(PB-2) with Grade Pay of Rs 3000/-per month plus other allowances as admissible under the Rules with effect from the date of their joining.

The services of the aforementioned candidates shall be governed by "The New Defined Contribution Pension Scheme" issued by the Government of Assam, Finance (Budget) Department vide Office Memorandum No. BW.7/2008/Pt/40 dtd. Dispur the 6th October, 2009. The selected candidates mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

The above candidates, if presently employed in Central/State Governments service shall submit release order from the former employer at the time of joining.

They are directed to join their duties within 15(fifteen) days from the date of issuance of this order.

They will be on probation for a period of 1 (one) year from the date of their joining.


