ORDER

Memo No.HC.VII-238/2013/ 1488 /A Dated Guwahati the 13th March, 2014.

Due to not joining of Smti. Devisandhya Sarma, subject to satisfactory Police Verification, **Smti. Indrani Baruah** is temporarily appointed on contractual basis as **Court Manager** in the District Court of Cachar district at Silchar against the posts created by the Govt. of Assam vide Notification No.JDJ.124/2011.21 dated 21.07.2012, at a consolidated pay of ₹ 50,000/- (Rupees Fifty thousand only) per month, with effect from the date of her joining. Appointment of the candidate is temporary and she may be terminated at any time without assigning any reason.

Smti. Indrani Baruah is directed to join her place of posting on or before 01.04.2014, positively and submit her joining report to the undersigned through the District & Sessions Judge, Cachar, Silchar.

The service of the aforementioned candidate shall be governed by the Gauhati High Court (Appointment and Conditions of Service of Court Managers) (Assam) Rules 2012.

The expenditure is debit to the Head of Account "2014-Admin. of Justice. 105 - Civil & Sessions Court-6341 - 13th Finance Commission -26- Other Charge General Non Plan (voted)" in the current year's Budget for 2012-2013.
