ORDER

No. HC.V-53/2013/ 506 / Estt.### Smti Kangkana Goswami is appointed temporarily and until further orders, as **Library Assistant** in the Principal Seat of the Gauhati High Court, Guwahati in the pay band of Rs. 14,000 - 49,000/- (P.B-2) with Grade Pay of Rs 7600/- per month plus other allowances as admissible under the Rules with effect from the date of her joining, vice Shri Mrinmay Kumar Das, Library Assistant promoted as Assistant Librarian, subject to the condition that in the event of adverse police verification report, the service of Smti Goswami will be terminated forthwith without assigning any reason whatsoever.

The aforementioned candidate is directed to submit her medical certificate of fitness from Medical Officer of Government or by any Medical Officer in Charge of a civil station at the time of joining.

Further, if the above candidate is presently employed in Central/State Government service, she shall submit a release order from the former employer at the time of joining.

The services of the aforementioned candidates shall be governed by "**The New Defined Contribution Pension Scheme**" issued by the Government of Assam, Finance (Budget) Department vide Office Memorandum No. BW.7/2008/Pt/40 dtd. Dispur the 6th October, 2009. The selected candidate mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

She will be on probation for a period of 1 (one) year with effect from the date of her joining. She is directed to join her duties within 15 (fifteen) days from the date of receipt of the order.
