Stenographer Grade-II	Shall be a Graduate with computer knowledge and diploma in shorthand having preferable speed of 100 w.p.m and preferable computer typing speed of 40 w.p.m. Shall also possess a Diploma in Stenography should be from a recognized institution.
Driver	<ol style="list-style-type: none"> <li>1. Matriculation or equivalent from a recognized Central or State Board.</li> <li>2. Must possess a valid <b>Transport Driving License</b>.</li> <li>3. Must have a minimum experience of at least 2 (two) years in driving passenger bus (minimum 36 seater)</li> </ol>
Duftry*	Matriculation or equivalent from a recognized Central or State Board.

\* **The post of Duftry is a Grade-IV post.** A person appointed in the said post will be required to perform duties such as sorting, arranging, numbering of files in orderly manner and assisting in presenting them as and when required as well as other works viz. binding, stapling of file, time keeper of the watches in the office premise, keeping track of stationary etc and other miscellaneous works as entrusted by the concerned authority.

**(b) PROOF OF RESIDENCY:**

A Candidate must possess a valid registration certificate of Employment Exchange for the State of Assam for all the aforesaid posts.

**5. SELECTION PROCESS:**

**For the post of Stenographer Grade-II**

	Voice test before dictation	2 minutes
	Speed test in shorthand at a speed of 100 words per minute (total 700 words)	7 minutes

	Time for transcription of the dictated portion in computer	25 Minutes
<b>In order to qualify in the Stenography Skill Test, the candidates shall have to secure minimum 50% marks i.e. 45 out of 90 marks.</b>		

<b>Stage II</b>	<b>Written Examination (Descriptive Type)</b>	<b>100 marks</b>
	Candidates equal to 10 (ten) times the number of vacancies (1:10) in order of merit in the Stenography test will be called for the written examination.	
	Written Examination will be of 2 hours duration on English language proficiency consisting of 80 marks on the touchstone of Composition, Essay and Grammar and 20 marks in the Assamese language segment. The Assamese language segment of the written examination will be of qualifying nature and candidates have to secure at least 40% marks in the Assamese language segment to be considered qualified in the written examination apart from the marks obtained in the English language segment.	
<b>The written examination will be of qualifying nature as well and marks obtained therein will not be considered while preparing the final select list.</b>		
<b>The Gauhati High Court Reserves the right to fix the cut off mark for the written examination.</b>		
<b>Stage III</b>	<b>Interview/Viva-Voce</b>	<b>30 marks</b>
	Candidates equal to 3 (three) times of the number of vacancies (1:3) in order of merit in the Stenography test will be called for Interview/Viva-voce subject to qualify in the Written Examination. The candidates shall have to secure a minimum of 60% in the Viva-voce in order to be selected in the final merit list.	
<b>The final selection may be made on the basis of marks obtained in Stenography test and Interview/Viva-Voce only. The candidates must possess working knowledge in the official language of the State of Assam i.e. Assamese.</b>		
Note: In case of candidates obtaining equal total marks, one who obtains more marks in the Stenography test will be given preference. Where marks obtained by such candidates in the Stenography test are also same, the candidate who is senior in age will be given preference.		

**For the post of Driver**

<b>Stage 1</b>	<b><u>Screening Test of qualifying nature:</u></b>
	<p>Screening Test (Objective Type multiple choices) on OMR sheets for 50 marks of 1 hour duration on OMR answer scripts testing the General knowledge (20 marks), Road Sign Recognition (20 marks) and Assamese language (10 marks).</p> <p>In order to qualify in the Screening Test a candidate shall have to secure the following:</p>

	<p><i>a) a minimum 5 marks out of 10 marks in the Assamese language segment</i></p> <p><i>b) Apart from the above, a minimum of 24 marks out of 40 marks of the remaining part of the Screening Test.</i></p> <p>The Written examination will be of qualifying nature and marks obtained therein will not be considered while preparing the final select list.</p>
<b>Stage 2</b>	<p style="text-align: center;"><b><u>Driving Test: 40 marks</u></b></p> <p>Candidates equal to 5 times of the number of vacancies (1:5) in order of merit in the Screening test will be called for Driving test.</p> <p>The Driving Test will be on the segments namely, Starting, Driving, Parking and After Driving (10 marks for each segment, total 40 marks).</p> <p>In order to qualify in the Driving Test, a candidate shall have to secure a minimum of 20 marks out of 40 marks in the Driving Test.</p>
<b>Stage 3</b>	<p style="text-align: center;"><b><u>Viva- voce: 10 marks.</u></b></p> <p>Candidates equal to 3 times the number of vacancies in order of merit in the Driving Test will be called for Interview/Viva-Voce.</p> <p>In order to qualify in the Interview/Viva-voce, a candidate shall have to secure a minimum of 60% marks.</p> <p>On the basis of the sum total of marks obtained in driving test and viva-voce, the final select list will be prepared.</p> <p>Where more than one candidate obtain same grand total marks (marks of driving test and viva-voce), the candidate who obtains more marks in the driving test will get preference. Where the marks obtained by such candidates in the driving test are also same, the candidate who is senior in age will get preference.</p>

**For the post Duftry**

<b>Stage 1</b>	<p style="text-align: center;"><b><u>Written examination of 70 marks</u></b></p> <p>Written Examination (Objective Type multiple choices) on OMR sheets for 70 marks of 90 minutes duration on OMR scripts testing the General knowledge, General English and Aptitude (50 marks) and Assamese language (20 marks).</p> <p>In order to qualify in the written examination a candidate has to secure a minimum of 8 marks out of 20 marks in the Assamese language segment. Marks obtained in the Assamese language segment will not be considered for preparation of final merit list.</p>

<b>Stage 3</b>	<p style="text-align: center;"><b><u>Viva- voce of 10 marks.</u></b></p> <p>Candidates equal to 3 times the number of vacancies in order of merit in the Written examination will be called for Interview/Viva-Voce.</p> <p>On the basis of the sum total of marks obtained in written examination and viva-voce the final select list will be prepared.</p> <p>Where more than one candidate obtain same grand total marks (marks of written examination and viva-voce), the candidate who obtains more marks in the written examination will get preference. Where the marks obtained by such candidates in the written examination are also same, the candidate who is senior in age will get preference.</p>

**HOW TO APPLY:** Before applying online, candidates must possess a valid e-mail ID and Mobile Number which are mandatory for registration. E-mail ID should be kept active. Though the system is designed to send e-mail immediately acknowledging the Registration Code, sometimes due to network congestion, the e-mail may not be delivered, hence the candidates are requested to note down the Registration Code.

Phase 1: (a) Log on through the website ***www.ghconline.gov.in*** and click on **"Online Application for various posts in the Judicial Academy Assam"**.

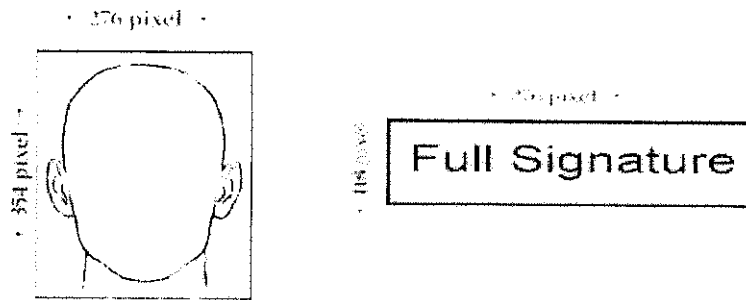
(b) Click on **"New Registration"**. Provide the required information in that page, and then click **"Submit Registration"**. The system will generate a Registration Code which will be displayed below the "Submit Registration" button. Though the system is designed to send e-mail immediately acknowledging the Registration Code and corresponding Date of Birth, sometimes due to network congestion, the e-mail may not be delivered. Hence, candidates are requested to note down the Registration Code carefully.

The combination of Registration Code and Date of Birth will be used as login details for next three Phases, i.e. Phase 2, Phase 3 and Phase 4.

Phase 2: (a) Click **"Update Candidate Details"**.

(b) Candidate has to provide his/her profile details and other candidature specific information and has to save the data by clicking the **"Update Data"** button. **No field box should be left blank.**

Phase 3: Candidate has to upload his/her Photograph Image and Signature Image. The image format should be either **.jpg, .png or .gif**. No other image format will be accepted. The image size should be between **5 KB and 30 KB**. Pixel size of photograph is 354 x 276 and for the Signature is 118 x 276. The dimension of the Photograph image and Signature image should be as indicated below:



The image of the Passport Photograph should be such that the face of the candidate covers at least 80% of the space of the photograph image, similarly the signature should cover at least 70% of space of the Signature image.

For uploading Passport Photo and Signature (both should be in image format as specified above),

- (a) Click **"Upload Photograph & Signature"**.
- (b) The candidate should select the respective file using the **"Browse"** button and after selecting the file, he/she should click the **"Upload Passport Photo"** and **"Upload Signature"** button respectively to upload the file to server.
- (c) On successful uploading of photo & signature, the candidate should click the "Declaration check box". On clicking the Declaration check box on the page, the button **Submit candidature** will turn green and will be activated for submission of candidature.
- (d) Click on **Submit candidature** to submit the application. No change in information filled in by the candidates will be allowed once the application form is submitted by clicking the **Submit candidature** button. Therefore, before submitting Candidature, please ensure that all information, photograph and signature are uploaded as per the instructions.

- Phase 4:
- (a) After submission of candidature, the candidate should take a print out of the Fee Payment Challan by clicking the **"Print Fee Payment Challan Form"** button.
  - (b) The payment can be made at any branch of State Bank of India after two working days of submission of online application and on or before the last date fixed for payment of fees.
  - (c) For payment, the candidate should approach the bank along with the Challan copy and the fee amount reflected on the Challan. On payment of the same, the Bank will provide a Journal Number. Please ensure to have the bank official's signature and seal on the Challan copy. Please keep the candidate's copy of the Challan carefully for any future reference.
  - (d) The fee payment information viz. Journal No., Paid Amount, Payment Date etc., will be reflected automatically on the account of the candidate after two working days from the date of payment at the bank.
  - (e) Thereafter, the applicant will be able to take printout of the

Acknowledgement receipt about his/her candidature.

- (f) Please print the Acknowledgement Receipt and Application Form generated by the system on this phase after completion of fee payment process for further reference.

7. **APPLICATION FEE:** The details of application fee to be paid by the candidates are indicated below. Persons with benchmark disability (PWBD) need not pay any fees.



8. Candidates are advised to apply online well before the last date and not to wait till the last date, so as to avoid heavy load on internet or website.

9. **TERMS AND CONDITIONS:**

- i. Candidates need not submit any testimonial/certificate at the time of submission of online application. However, candidates have to produce their original testimonials regarding educational qualifications, computer qualifications, date of birth, caste, working experience etc. at subsequent stages when asked for.
- ii. The admission of candidates at all stages of the selection process will be purely provisional and subject to satisfying the prescribed eligibility conditions. The application will be subject to scrutiny at every stage and shall be rejected if any defect is detected.
- iii. The list of provisional candidates, with allotted Roll Nos. will be published in the High Court website for the candidates' reference.
- iv. No TA/DA shall be paid to the candidates for appearing in the written test/skill test/interview etc.
- v. Candidates who are already in the Government Service (Central/State or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present Employer at the time of document verification before interview/viva-voce and they will have to submit release order at the time of joining.


