The Gauhati High Court has been pleased to notify that Written test (Objective Type Questions with Multiple Choices) on OMR (Optical Mark Recognition) answer scripts & Skill test for direct recruitment of Stenographers Grade-III for the Subordinate courts of Assam will be held in Guwahati on 10-5-2014(Saturday) & 11-5-2014 (Sunday) respectively as per the Schedule indicated herein in terms of advertisement dated 20-2-2014. In the event of non-completion of skill test on the same day, candidates will be informed the next date in due course.

It is further notified that the all candidates, who have applied in response to advertisement dated 7-2-2013 & 20-2-2014, have been included in the list, published along with this notification. All the candidates are provisionally allowed to appear in the written test & skill test. Please note that candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 7-2-2013 and advertisement dated 20-2-2014. Provisionally allowing the candidates to appear in the written test & skill test does not necessarily mean acceptance of their candidatures which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent time.

All candidates will have to download and take Printout of their Admit Cards from the Official Website of Gauhati High Court (www.ghconline.gov.in) between 11.00 am of 30-4-2014(Wednesday) to 5:00 pm of 9-5-2014 (Friday). The candidates shall bring the Admit Cards, candidate's copy of the Fee Payment Challan along with black/blue ball point pen while appearing in the written test & skill test. Venue of the written test & skill test will be indicated in the Admit Card along with other details.
