ORDER

Dated Guwahati the 14th November, 2023

No. HC.V-34/2020/113 /Estt. (Pt.) ### In partial modification of this Registry's earlier order No. HC.V-34/2020/855/Estt.(Pt.) dated 16/10/2023, the engagement of candidate at Sl. No. 3 of the said order stands cancelled as the said candidate has not reported for joining within the time specified in the aforesaid order. In lieu thereof, candidate at Sl. No. 8 of this Registry's earlier Notification No. HC.XXXVII-16/2023/606/R.Cell dated 10/10/2023, **Shri Bhaskar Jyoti Sarma**, is hereby temporarily engaged as **Law Clerk** in the Principal Seat of the Gauhati High Court at a consolidated pay of Rs. 30,000/- (Rupees thirty thousand) only per month, initially for a period of 2 (two) years with effect from the date of his joining, subject to the condition that in the event of adverse police verification report, service of the candidate will be terminated forthwith without assigning any reason whatsoever.

The candidate shall not have any claim of regular/permanent appointment, whatsoever, as a matter of right and his engagement may be terminated at any time without assigning any reason. Further, he has to submit an undertaking in writing at the time of joining stating his strict adherence to the code of conduct and duties & functions of Law Clerk.

The aforesaid candidate is directed to submit his medical certificate of fitness to this Registry from Medical Officer of Government or by any Medical Officer In-Charge of a civil station at the time of joining. Further, if he is presently employed in Central/State Government service, he is directed to submit release order from the former employer at the time of joining.

The abovementioned candidate is directed to join his duty within 15 (fifteen) days from the date of receipt of this order.
