**CORRIGENDUM**


In partial modification of this Commission's Vacancy Circular No. A-2/Recruitment/NCDRC/17-18 (Vol.II) dated 11.05.2022, the following changes may be read as under:-

1. The pay matrix level for the post of Accounts Officer may be read as Level 7: ₹44,900-₹142400/- instead of Level 8: ₹47,600-₹1,51,100/-.
2. The pay matrix level for the post of Accountant-cum-Cashier may be read as Level 6: ₹35400-₹112400/- instead of Level 7: ₹44,900-₹142400/-.
3. The number of posts for the Section Officer may be read as 02 (Two) nos. instead of 01 (One) no.
4. The vacancy for the post of Assistant is hereby cancelled in view of the notified Recruitment Rules of Group 'B' posts and to be filled up by way of direct recruitment.
5. The vacancy for the post of Court Master (Non-Shorthand) is hereby cancelled due to Administrative reasons.
6. The last date of submission of application for the posts of Section Officer in Pay Matrix Level-8: ₹47,600-₹1,51,100/-, Accounts Officer in Pay Matrix Level-7: ₹44,900-₹1,42,400/-, Accountant-cum-Cashier in Pay Matrix Level-6: ₹35,400-₹1,21,400/- and Personal Assistant in Pay Matrix Level-6: ₹35,400-₹1,21,400/- on deputation basis is extended upto 20.05.2023.

Those who have already applied for the above said posts, will be considered and need not apply again.


Remaining contents of the vacancy circular dated 11.05.2022 shall remain unchanged.




