The candidates are also directed to submit a copy of the admit card of the written examination and two recent passport size color photographs. The self-attested photocopies of the documents shall have to be handed over at the time of the Interview/Viva-voce. Those candidates who are already employed in the Central/State Govt. Service or Undertakings shall have to produce *No Objection Certificate* (NOC) from the present employer.

Calling of the aforementioned candidates to the Interview/Viva-Voce is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility at any stage. 
