

The candidates shall bring all testimonials related to educational qualification, two recent passport size color photographs, documents related to work experience etc., in original, along with a set of self-attested photocopies. The self-attested copies are to be handed over at the time of the Viva-voce/ Interview. The candidate shall have to produce a No Objection Certificate (NOC) from the present employer at the time of document verification and release order at the time of joining.

Provisional list of candidates with assigned Roll Numbers have been published along with this notification. A list of candidates, whose candidature has been rejected on the grounds mentioned against their names, has also been published. Candidature of the provisionally eligible candidates are subject to fulfillment of all the criteria mentioned in the advertisement dated 20.12.2023. 
