Dispur the 6<sup>th</sup> October, 2009. The selected candidate mentioned above will have to submit an undertaking to that effect at the time of joining in this office.

He will be on probation for a period of 1 (One) year with effect from the date of his joining. He is directed to join the duty within 15 (fifteen) days from the date of receipt of the order.
