
No individual call letter will be issued to any candidate.

Calling of the aforementioned candidates to the Viva-voce/Interview is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the Gauhati High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility at any stage.
