1.	Written Examination (Objective Type Multiple Choice)	
	Four different Written Examinations (Objective Type Multiple Choices) of 1½ hours duration each on OMR answer scripts will be held consisting of questions on <i>Technical area (35 marks), General Knowledge and General English (15 marks)</i> for each category of posts. Questions on Technical area will be as per description given in the eligibility criteria of the advertisement for each post. The High Court reserves the right to fix cut off mark for the written examinations for each post.	50 Marks 1½ hours
2.	Viva Voce/Interview	
	Thereafter, candidates in the ratio of 1:3 (Three candidates against one vacancy) in order of merit in the written examination will be called for the viva voce. On the basis of the total marks obtained by the candidates in the written examination and the viva voce the final select list for each category of posts will be prepared. Where more than one candidate, obtain same total marks, the candidate who obtains more marks in the written examination will get preference. Where the marks obtained by such candidates in the written examination are also same, the candidate who is senior in age will get preference.	20 Marks

All the candidates of the provisional list have been allowed to appear in the respective written examinations purely on provisional basis with the condition that their eligibility is still under scrutiny and the High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.


