Pursuant to the advertisement dated 6-8-2015 in connection with recruitment of supporting staff for the Foreigners Tribunals of Assam, the Gauhati High Court has been pleased to notify that a **Common Written Examination (Objective Type Multiple Choices)** of 100 marks on OMR (Optical Mark Recognition) answer scripts for the posts of **Bench Assistant, Lower Division Assistant, Stenographer and Typist** will be held on 8-11-2015 (Sunday) from 10.00 AM to 12.00 PM (Morning Session).

Another **Common Written Examination (Objective Type Multiple Choices)** of 100 marks on OMR (Optical Mark Recognition) answer scripts for the posts of **Data Entry Operator and Copyist** will be held on the same day i.e. 8-11-2015 (Sunday) from 2.00 PM to 4.00 (Afternoon Session).


All the candidates, who have been included in the two lists, published in the official website of the High Court along with this notification, are allowed to appear in the

The candidatures of all the candidates are still under scrutiny and the High Court reserves the right to reject their candidatures at any time and that they are allowed to appear in the examinations purely on provisional basis subject to final scrutiny of their applications at appropriate stage. Further, candidatures of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 6-8-2015. No T.A/D.A will be paid to the candidates for appearing in the examinations.

If any applicant has any grievance(s) regarding inclusion/non-inclusion of his/her name in the published lists of candidates, he/she may bring the same to the notice of the undersigned during office hours within a period of 10 (Ten) days from the date of publication of the lists of candidates.

All the candidates will have to download and take Printout of their Admit Cards from the Official Website of the High Court ([www.ghconline.gov.in](http://www.ghconline.gov.in)) w.e.f 11.00 am of 2-11-2015 (Monday) till the date of the examinations. The candidates shall bring the Admit Cards, along with black/blue ink ball point pen while appearing in the examination. Venue of the examination will be indicated in the Admit Card along with other details.
