**Specific venue of the examination will be indicated in the Admit Cards.**



A provisional list of candidates with assigned Roll Numbers and a reject list along with reasons for rejection have been published along with this notification.

Candidates named in the provisional list are allowed to appear in the Preliminary Examination subject to the condition that their candidature will continue to be under scrutiny. The Gauhati High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.

**It should be noted that no candidate will be allowed to enter the examination centre without wearing a face mask. Candidates shall have to strictly adhere to the social distancing norms inside and outside the examination centre.**


