
**No individual call letter will be issued to any candidate in any mode.**

Candidates are directed to bring all the relevant testimonials relating to age proof (Class X admit card/birth certificate), educational qualification(s), certificate of indigenous inhabitant of Nagaland issued by competent authority, valid LMV driving license issued by competent authority, experience certificate (if any), category certificate (if applicable) in original along with a set of self-attested photocopies. The candidates are also directed to submit a copy of the admit card of the written examination/driving test and two recent passport size color photographs. The self-attested photocopies of the documents shall

have to be handed over at the time of the Interview/Viva-voce. Those candidates who are already employed in the Central/State Govt. Service or Undertakings shall have to produce *No Objection Certificate* (NOC) from the present employer.
