1. Applications are invited from intending candidates, for filling up of **3 (Three)** vacant posts in **Grade-III** of the Arunachal Pradesh Judicial Service (to be created by Arunachal Pradesh Govt. shortly) which may be extended upto **5(Five)** if the Hon'ble High Court has to fill up all the posts in the pay scale of Rs.27700-770-33090-920-40450-1080-44770 per month plus other allowances as admissible under the Rules. Therefore the number of vacancies may vary at the time of appointment.
2. **Eligibility Criteria:**
 - a) **Age:** Must not have completed, as on the last date fixed for receipt of applications, 38 years of age in case of candidates belonging to Arunachal Pradesh Scheduled Tribes and 35 years in case of others.
 - b) **Educational Qualification:** Must be holder of a Degree in Law from a recognized University.
 - c) **Citizenship:** Must be a citizen of India as defined in Articles 5 & 6 of the Constitution of India.
3. 80% of the posts to be filled up by Direct Recruitment are reserved for candidates belonging to the Arunachal Pradesh Scheduled Tribes (APST) and the remaining 20% of the posts are to be filled up from the General category candidates.
4. No application will be accepted after the closing date. Attested copies of certificates of proof of his/her educational qualification, Bar Council's Registration (if any), Age certificate along with 2 (two) copies of recent passport size photograph duly attested should be submitted alongwith the Application Form. An **IPO (Indian Postal Order)** of **Rs. 200/-** (Rupees Two Hundred only) for General candidates and **Rs. 100/-** (Rupees One Hundred only) in case of APST candidates should be made payable to the **Deputy Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh.**

7. The candidates shall have to appear in a **written examination** consisting of the following papers:

Paper-I: English (100 Marks)

- a) Essay Writing
- b) Précis Writing
- c) Grammar etc.

Paper-II: General Knowledge (100 Marks)

- a) Objective Type
- b) Aptitude Test

Paper-III: Law Paper-I (100 Marks)

- a) Constitution of India
- b) Code of Civil Procedure
- c) Transfer of Property Act
- d) Indian Contract Act

Paper-IV: Law Paper-II (100 Marks)

- a) Indian Penal Code
- b) Code of Criminal Procedure
- c) Indian Evidence Act
- d) Law of Tort

Note: The candidate is expected to refer to the relevant decisions of the Apex Court and the High Court while writing answers in Papers III and IV.

8. All the candidates who clear the written examination shall be called for the **Viva-Voce** Examination of 70 marks. Candidates belonging to the Arunachal Pradesh Scheduled Tribes, who obtain 50% or more marks and other candidates who obtain 60% or more marks in the written examination, shall be eligible for viva-voce.
9. The written test/viva voce test and all other conditions for appointment shall be as per the Arunachal Pradesh Judicial Service Rules, 2006. The candidates shall have to appear in the written test/viva voce examination at their own expense, as and when called for.
10. **The number of posts advertised is newly created vacancies only. Mere selection would not per se entitle a candidate to claim appointment.**
