Candidates are directed to bring all testimonials in **original** including educational qualifications, caste certificate and driving licence etc. along with a set of self-attested photocopies of above documents and shall hand over the same to the undersigned for scrutiny before the commencement of the interview.

Candidates who are presently employed in Central or State Govt. Services will be required to produce a "No Objection Certificate" in the event of his selection.

Calling of the candidates to the interview is **purely provisional** and does not necessarily mean acceptance of their candidatures, which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature at any time on detection of any ineligibility condition. The candidature shall be subject to fulfillment

of all the criteria mentioned in the advertisement dated 09-12-2013. No TA/DA will be paid to the candidates.


