## **ORDER**

**No. HC.V-43/387 / 2018/Estt. ###** The following persons are appointed temporarily and until further orders, in the post of Chauffeur in the Principal Seat of the Gauhati High Court in the pay band of Rs. 14000-60500/- (P.B-2) with Grade Pay of Rs 5200/- per month plus other allowances as admissible under the Rules with effect from the date(s) of their joining, subject to the condition that in the event of adverse police verification reports, their services will be terminated forthwith without assigning any reason whatsoever.

Dispur the 6th October, 2009. The selected candidates mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

They will be on probation for a period of 1 (one) year with effect from the date(s) of their joining. They are directed to join their duties within 15 (fifteen) days from the date of receipt of the order.
