On transfer of Sri Iftekar Hussain Ahmed, subject to satisfactory Police Verification, Smti. Devisandhya Sarma is temporarily appointed on contractual basis as **Court Manager** in the District Court of Cachar district at Silchar against the posts created by the Govt. of Assam vide Notification No.JDJ.124/2011.21 dated 21.07.2012, at a consolidated pay of ₹ 50,000/- (Rupees Fifty thousand only) per month, with effect from the date of her joining.
