The written Examination for direct recruitment to Grade-I and Grade-II stenographers of the Principal Seat of Gauhati High Court will be held on 21-04-2013 in terms of the Advertisement dated 07-02-2013. The skill test for Grade-I and Grade-II stenographers will be conducted on 27-04-2013 and 28-04-2013 respectively.

Please note that candidature of the applicants shall be subject to fulfilment of all the criteria mentioned in the advertisement dated 12-01-2013. No TA/DA will be paid to the candidates for appearing in the written examination.

All the candidates will have to download and take printout of the admit cards from the Official Website of Gauhati High Court (www.ghconline.gov.in) between **11.00 AM of 15-04-2013 to 5.00 PM of 19-04-2013**. If any candidate fails to download the 'Admit Card' from the website, he/she may contact in person the Recruitment Cell of Gauhati High Court at Guwahati on 20-04-2013 from 10.30 AM to 4.00 PM. On the day of the written test and skill test, the candidates shall bring their Admit Cards to the examination hall. Venue of the examination will be indicated in the Admit Card along with other details. Allowing the candidates to appear in the written examination and skill test does not necessarily mean acceptance of their candidatures, which will be further scrutinized.


