In terms of the selection process notification dated 09-03-2017 the marks obtained in the written test is of qualifying nature and marks obtained therein will not be considered while preparing the final select list. On the basis of the total marks obtained by the candidates in the Stenography Test and the Viva voce, the final select list will be prepared.

Calling of the aforementioned candidates to the Stenography Test is purely provisional and does not necessarily mean acceptance of their candidatures, which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any time. The candidature of the candidate shall be subject to fulfilment of all the criteria mentioned in the advertisement dated 23-12-2016. No TA/DA will be paid to the candidates for appearing in the abovementioned examination.
