No. HC.V-46/2024/ 535 /Estt. ### Shri Debasish Sarmah is hereby appointed temporarily and until further order(s), in the post of **Programmer** in the Principal Seat of the Gauhati High Court in the pay band of Rs. 22000-97000/- (Pay Band-3) and Grade Pay of Rs. 11800/- per month plus other allowances as admissible under the Rules with effect from the date of his joining, subject to the condition that in the event of adverse police verification report, his services will be terminated forthwith without assigning any reason whatsoever.

The aforementioned candidate is directed to submit his medical certificate of fitness from a Medical Officer of Government or by any Medical Officer In-Charge of a Civil Station at the time of joining.

Further, the above candidate, if presently employed in Central/State Government service, is directed to submit release order from the former employer at the time of joining.

The service of the aforementioned candidate shall be governed by "**The New Defined Contribution Pension Scheme**" issued by the Government of Assam, Finance (Budget) Department vide Office Memorandum No. BW.7/2008/Pt./40 dated Dispur the 6th October, 2009. The selected candidate mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

He will be on probation for a period of 1 (one) year with effect from the date of his joining.

He is further directed to join his duty within 15 (fifteen) days from the date of receipt of this Notification.


