The Gauhati High Court has been pleased to notify that driving test for direct recruitment of Driver (Barkandaz) for the Principal Seat of the Gauhati High Court will be held at **Guwahati** from 20-9-2014 to 27-9-2014 (Total 8 days) as per the Schedule of Driving Test indicated herein.

It is further notified that the all candidates who have been included in the list, published in the official website along with this notification, are provisionally allowed to appear in the driving test. The candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 9-12-2013. The scheme of selection is as follows:

(A) Driving Test: 50 marks(B) Viva-Voce: 10 marks

Candidates shall be called to the viva-voce in the ratio of 1:3 from the rank wise list of marks obtained in the driving test. Final selection shall be made on the basis of overall suitability to be determined by the High Court.

Admit Cards are being issued to the candidates. They are to report at the venue as per the date and time indicated below. If any candidate does not receive the Admit Card till 17-9-2014 (Wednesday), he/she may collect the same in person from the Recruitment Cell of Gauhati High Court (Old Block) at Guwahati on 18-9-2014 (Thursday) during office hours.

The candidates shall bring the Admit Cards while appearing in the driving test. Allowing the candidates to appear in the driving test does not necessarily mean acceptance of their candidatures which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent time.
