The Gauhati High Court has been pleased to notify that the Preliminary Examination (Objective Type Questions with Multiple Choices) of 100 (one hundred) marks for direct recruitment to Grade-III of Arunachal Pradesh Judicial Service will be held as per schedule indicated below. Objections/clarifications etc., if any, in respect of the published lists of candidates are to be brought to the notice of the Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh on or before 09-03-2017 during office hours.

Admit cards will be issued to the candidates by post. Venue of the exam will be indicated in the Admit card of the respective candidates. If any candidate does not receive his/her admit card on or before 17-03-2017, he/she can collect the same in person from the Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh on 18-03-2017 during office hours. No T.A/D.A will be paid to the candidates for appearing in the written examination.

It is notified that all the candidates of the provisional list at List-A have been allowed to appear in the preliminary examination. However, the candidature of the applicants shall be subject to fulfilment of all the criteria mentioned in the advertisement dated 09.11.2016. The Gauhati High Court reserves the right to reject the candidature of any candidates at any subsequent stage.


