ORDER

Memo No. HC.VII-238/2013/9301/A

Dated Guwahati the 27th November, 2013

Subject to satisfactory Police Verification the following candidates are temporarily appointed on contractual basis as Court Managers in the Principal Seat of the Gauhati High Court as well as in the District Courts of Assam against 23 (twenty three) posts created by the Govt. of Assam vide Notification no. JDJ. 124/2011.21 dated Dispur the 21st July, 2012, at a consolidated pay of Rs. 50,000/- (Rupees fifty thousand only) per month, with effect from the date of their joining. Appointments of the candidates are temporary and may be terminated at any time without assigning any reason.

All the selected candidates are directed to join their place of posting as shown below.
