1. Applications are invited from Advocates for filling up of 1 (one) existing post in Grade-I of the Arunachal Pradesh Judicial Service in the pay scale of Rs.51,550-1230-58,930-60,070/- per month plus other allowances as admissible under the Rules. If more posts become available before completion of selection process filling up of such post will be considered.

2. Eligibility Criteria:

- a) Age: Must not be less than 35 years of age and must not have completed, 48 years of age in case of candidates belonging to Arunachal Pradesh Scheduled Tribes and 45 years in case of others as on the last date fixed for receipt of applications.
- b) Educational Qualification: Must be holder of a Degree in Law from a recognized University.
- c) Experience: Must be practising as an advocate in Courts of Civil and Criminal jurisdiction on the last date fixed for receipt of applications and must have so practised for a period of not less than 7 (Seven) years as on the last date fixed for receipt of applications.
- d) Citizenship: Must be a citizen of India as defined in Articles 5 & 6 of the Constitution of India.
- 3. 80% of the posts to be filled up by Direct Recruitment are reserved for candidates belonging to the Arunachal Pradesh Scheduled Tribes (APST) and the remaining 20% of the posts are unreserved.
- 4. No application will be accepted after the closing date. Attested copies of certificates of proof of his/her educational qualification, Bar Council's Registration, Age and Practice certificate along with 2 (two) copies of recent passport size photograph duly attested should be submitted alongwith the Application Form. An IPO (Indian Postal Order) of Rs. 500/- (Rupees Two Hundred only) for General candidates and Rs. 250/- (Rupees One Hundred only) in case of APST candidates should be made payable to the Deputy Registrar, Gauhati High Court, Itanagar Permanent Bench, Naharlagun, Arunachal Pradesh. Furnishing of false information/document will be entirely at the peril of the candidates.

7. The candidates shall have to appear in a written examination consisting of the following papers:

<u>Paper-I</u>: One paper of 100 marks (duration 3 hours) to test the General Knowledge, aptitude, intelligence, test of comprehension and expression of law and General English including Essay Writing on legal Topic and information technology.

Paper-II: One paper of 100 marks (duration 3 hours) regarding objective questions and problems of law as regards the Transfer of Property Act, Civil Procedure Act, Code of Criminal Procedure, Indian Evidence Act, Indian Penal Act, Limitation Act.

Paper-III: One paper of 100 marks (duration of 3 hours) consisting of Judgement Writing (Paper book to be supplied)-Legal theories on Jurisprudence, provision of Constitution.

Note: The candidate is expected to refer to the relevant decisions of the Apex Court and the High Court while writing answers in Papers II and III.

- 8. Candidates belonging to the Arunachal Pradesh Scheduled Tribes, who obtain 50% or more marks and other candidates who obtain 60% or more marks in the written examination shall be eligible for viva-voce. Number of candidates to be called for interview/viva-voce (carrying 50 marks) will be three times (1:3) against the number of posts advertised.
- 9. In the viva-voce out of 50 marks the candidates will have to secure minimum 60% marks. The final selection shall be made subject to overall suitability of the candidate
- 10. The written test/viva voce test and all other conditions for appointment shall be as per the Arunachal Pradesh Judicial Service Rules, 2006. The candidates shall have to appear in the written test/viva voce examination at their own expense, as and when called for.
- 11. The number of posts advertised is newly created vacancies only. Mere selection would not per se entitle a candidate to claim appointment.
