## **ORDER**

Dated Guwahati the 28<sup>th</sup> August, 2024

**No. HC.V-69/2014/ 757 /Estt. (Pt.-1) ### Smt. Bidikha Gogoi** is hereby temporarily engaged as **Law Clerk** in the Principal Seat of the Gauhati High Court at a consolidated pay of Rs. 30,000/- (Rupees thirty thousand) only per month initially for a period of 2 (two) years with effect from the date of her joining, subject to the condition that in the event of adverse police verification report, service of the candidate will be terminated forthwith without assigning any reason whatsoever.

The candidate shall not have any claim of regular/permanent appointment, whatsoever, as a matter of right and her engagement may be terminated at any time without assigning any reason. Further, she has to submit an undertaking in writing at the time of joining stating her strict adherence to the code of conduct and duties & functions of a Law Clerk.

The aforesaid candidate is directed to submit her medical certificate of fitness to this Registry from Medical Officer of Government or by any Medical Officer In-Charge of a civil station at the time of joining.

Further, the above candidate, if presently employed in Central/State Government service, is directed to submit release order from the former employer at the time of joining.

The abovementioned candidate is directed to join her duty within 15 (fifteen) days from **1<sup>st</sup> September, 2024**, positively.
