No individual call letter will be issued to any candidate in any mode.

*The aforesaid candidates are directed to submit his/her preference of Grade IV post i.e Court Attendant and Chowkidar in the "Preference Form" annexed with this notification. The candidates shall duly fill up the form and submit a scan copy of the same via email @ ghc.rcell2013@gmail.com from their registered email Id on or before **13-10-2023 till 5 pm.** The subject of the email should be clearly mentioned as "PREFERENCE FORM".*

Merely submitting preference of post by a candidate will not entitle him/her to claim right to appointment in his/her preferred post. The High Court will make the final allocation of post strictly on the basis of merit-cum-preferences opted by candidates. If no preference is

received, it will be the discretion of the Gauhati High Court to finally recommend a candidate to any of the vacant Grade IV post subject to his/her final selection on the basis of merit and availability of post thereof.

The aforesaid candidates are directed to bring all the relevant testimonials relating to age proof, educational qualification(s), experience certificate (if any), category certificate (if applicable) in original along with a set of self-attested photocopies. The candidates are also directed to submit a copy of the admit card of the written examination and two recent passport size color photographs. The self-attested photocopies of the documents shall have to be handed over at the time of the Interview/Viva-voce. Those candidates who are already employed in the Central/State Govt. Service or Undertakings shall have to produce *No Objection Certificate* (NOC) from the present employer.

Calling of the aforementioned candidates to the Interview/Viva-Voce is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate on detection of any ineligibility at any stage. The candidature of the candidates shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 10-04-2023. No TA/DA will be paid for appearing in the Interview/Viva-Voce.
