Sub: Request for latest vacancy position of Stenographers in the light of Hon'ble Committee's resolution dated 20-07-2013.

Sir/ Madam,

With reference to the subject cited above, I am directed to inform you that the Hon'ble High Court has been pleased to direct that the recruitment of Stenographers for subordinate judicial establishments should be carried out in terms of the recommendations of Shetty Commission, as accepted by the Hon'ble Supreme Court i.e.,

1. Stenographer Grade-III, by Direct Recruitment.
2. Stenographer Grade-II, 50% by promotion from Grade-III and 50% by Direct Recruitment.
3. Stenographer Grade-I, by promotion from Stenographer Grade-II.

However, under the present circumstances, the Hon'ble High Court provides for the following scheme as a one-time measure pending framing of Subordinate Court Establishment Rules of Assam:

- i. Irrespective of any grade and educational qualification they possess, existing Stenographers, who have completed 15 (fifteen) years of service, be promoted as Grade-I Stenographers, subject to such criteria as regards speed test etc. which the High Court may fix on availability of vacancy(s).
- ii. Irrespective of their educational qualification they possess, existing Grade-III Stenographer, who have completed 5 (five) years of service, be promoted as Grade-II Stenographers, subject to such criteria as regards speed test etc. which the High Court may fix against 50% of the sanctioned strength on availability of vacancy(s).
- iii. For the aforesaid promotions/appointments, eligibility criteria i.e., Speed test etc. to be determined by the High Court.

Therefore, you are requested to send information regarding the latest vacancy position (Gradewise), showing distinctly the number of sanctioned, existing vacancy and posts that are to be filled up through promotion as well as through direct recruitment.

The information is to be furnished in the following format and must be sent to the Recruitment Cell through a return fax (0361-2733823) latest by 06-09-2013 (Friday).


