CIRCULAR

Applications are invited for filling up of the post of Joint Registrar in Armed Forces Tribunal, Principal Bench, New Delhi on deputation basis/on re-employment on contract basis for a period of one year from suitable candidates who fulfill the following eligibility conditions :-

(a) holding analogous post on regular basis in the parent Cadre or Department. (b) With five years regular service in the parent cadre or Department in a post in pay Band 3 – Rs.15,600 – 39100 with grade pay Rs. 6600/-. (c) having 10 years of experience in personnel and administrative or judicial work. Note 1 : The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion. Note 2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall not ordinarily exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application. 2. For Re-employment on contract basis :- With similar qualifications and eligibility as for deputation.



2. The pay of the officer selected on deputation basis shall be governed by DoP&T O.M. No. 6/8/2009-Estt (Pay-II) dated 17.06.2010, as amended from time to time.

3. The maximum age limit for re-employment on contract basis is 64 years. The gross pension will be reduced from the pay fixed.

4. The application(s) in the prescribed Proforma (Annexure I) of the eligible officer(s) who can be spared for deputation in the event of their selection may be forwarded to the Principal Registrar, AFT, Principal Bench, West Block-8, Sector-I, RK Puram, New Delhi -110066 by the Departments latest by **30th October, 2015 (Friday)** along with photo copies of the confidential reports for the last five years of the candidates.

The applicant(s) interested in applying for the post of Joint Registrar on re-employment on contract basis for a period of one year may send their application(s) directly by the aforesaid date along with all the relevant documents like, PPO, LLB certificate, date of birth certificate, LPC and experience certificate for 10 years in personal and administrative or Judicial work.
