Sir / Madam,

With reference to the subject cited above, I am directed to inform you that the Hon'ble High Court has been pleased to schedule the date of written examination (Objective type) in connection with direct recruitment of staff in the establishments of all the Subordinate Judiciary in the state of Assam on 30-06-2013 (Sunday) from 11.00 am to 1.00 pm.

In this regard, admit card has to be made available to all the candidates for downloading from 17-06-2013 onwards. As such, venue for examination needs to be finalized at the earliest for mentioning the same in the Admit Cards.

Therefore, you are to immediately finalise the following details and revert back to the Recruitment Cell by return <u>Fax No 0361-2733823</u>, latest by **07-06-2013** (Friday):

- 1. 1 (one) convenient centrally located venue (school/college/any other institution) in your district which has the required infrastructure to accommodate the candidates as shown against your district may be fixed.
- 2. Prepare specific seat plan in consultation with the Head/In charge of proposed examination centre, consisting of (a) total number of candidates that can be accommodated in the venue, (b) number of rooms that would be utilized, (c) number of candidates that can be accommodated in each of the rooms. A separate sheet showing the district wise allotment of Roll Numbers has been annexed with this letter for preparing seat plan.
- 3. Total rate of the venue charges, and any other consequential expenses charged by the examination centre, duly signed and stamped by the Institutional head/ Centre in Charge and the same should be duly signed and forwarded by the District Judge concerned. Kindly arrange 2 invigilators per room (For up to 40 candidates), 3 invigilators (up to 60 candidates) and 4 invigilators (For 60 to 100 candidates) per room.
- 4. Other details of consequential expenses to be incurred for providing refreshment to the Officers and staffs engaged in the examination duty shall be duly signed and forwarded by the District Judge concerned.

It may be noted here that the High Court has been pleased to entrust the Recruitment Cell of High Court to supervise and co-ordinate with the district authorities in smooth conduct of examination and has been pleased to constitute District Examination Committees with the District Judge, Addl. District Judge, CJM and Addl CJM as members of the committee and in absence of any member(s) senior most officer(s) at the station as member(s).

The following District Judicial Establishments will have to undertake an additional responsibility of conducting examination where no judicial establishment has yet been made functional:

- 1. The District Judge Establishment and CJM Establishment of Nalbari are to hold examination for Baksa District in a separate venue or in separate rooms within the same venue fixed, for the district.
- 2. The District Judge, Bongaigaon will have to conduct examination for Chirang District at Bijni with the assistance of SDJM (M) apart from conducting examination at Bongaigaon.
