- 2. Earnest Money of ₹ 10,000.00 (Supees ten thousand) only should be submitted along with the quotation in the form of bank draft drawn in favour of Registrar General, Gauhati High Court, Guwahati, issued by any Nationalized/Scheduled Bank payable at Guwahati or unconditional Bank Guarantee valid upto during continuation of the contract.
- 3. One bidder may submit tender / quotation for different groups but separately in a sealed envelope addressed to the Registrar General, Gauhati High Court, Principal Seat at Guwahati, duly mentioning the Group / Groups for which he intends to submit tender / quotation along with the following documents:
