NOTICE INVITING TENDER

Sealed quotations are invited affixing Court Fee stamp of Rs.8.25 (Non-refundable) from the intending registered firms for supply of Liveries for the male and female Class- IV employees of Gauhati High Court, Principal Seat at Guwahati, for the years 2011 – 2013 as per specification given below.

1. Button up white terry cotton coat (Achkon) with 5" waist belt with 2 nos. golden lace stripes on white back ground on the sleeves (for Jamadars).
2. Button up white terry cotton coat length to reach below the buttock in each case with 3" white drill with 3 ½ brass buckle with runner (for Barkandaz).
3. White terry cotton long pant (for Jamadars and Barkandaz).
4. Grey coloured Safari for Attender /Orderlies /Darwans /Pumpman /Malies /Xerox machine operators /Sweepers etc. length to reach the buttock in each case for Attender /Orderlies /Darwans /Pumpman /Malis and Sweepers.
5. Brown coloured cap with as per approved pattern for Attender /Orderlies /Darwans /Pumpman, white cap for Barkandazes and white Turban with golden kullah and golden frings (double) for Jamadars.
6. Terry cotton Saree (Sky Blue & Light pink) stitched with fall etc., cotton petticoat and blouse for lady Class IV employees.

GENERAL TERMS & CONDITIONS

1. A processing fee of Rs.1000.00 (non-refundable) in the form of Bank Draft pledged to the Registrar General, Gauhati High Court, from any Nationalized / Scheduled Bank, shall be enclosed along with the quotation.
2. Earnest Money of Rs.10,000.00 (Rupees ten thousand) only should be submitted along with the quotation in the form of bank draft drawn in favour of Registrar General, Gauhati High Court, Guwahati, issued by any Nationalized/Scheduled Bank payable at Guwahati or unconditional Bank Guarantee valid upto during continuation of the contract.
3. The sealed envelope duly marked as "*Tender for Supply of Liveries for the Class- IV employees*" and the quotation should contain the following documents:
 - a) Copy of PAN Card.
 - b) Upto date copy of VAT clearance Certificate.
 - c) Copy of Gauhati Municipal Corporation Trade Licence.
 - d) An established showroom or shop of respective products.

Each page of the documents should be signed by the bidder, with seal, on each page of each document, to establish the Bidder's eligibility to the bid & his qualification to perform the supply of material if his bid is accepted. In the absence of any of the above documents/ information's, the offer may be summarily rejected without making any further reference in this regard.

The sealed envelope should be submitted to the Registrar General of the Gauhati High Court, Principal Seat at Guwahati.

4. The bidder must provide the sample of the material/items, which he intends to supply. The sample after the sale process is over will be returned. In the event, the supplied items do not match the sample provided; the material will be summarily rejected without any payment.
5. If the material received do not conform to the description and quality with the approved sample or have deteriorated (and the decision of the Registrar General in that behalf will be final and conclusive) the Registrar General will be entitled to reject the said items or such portion, thereof as may be discovered not to conform to the said description and quality. On such rejection the material will be replaced by the firm at its cost.
6. In case the successful bidder fails to submit the required material/ Liveries or the quality of Liveries is not up to the mark/standard, the EMD of the bidder shall be forfeited and the tender approved shall be cancelled. *Thereafter, next successive bidder may be considered.*
7. In the event of any breach of any terms and conditions or delay or default, the purchase order will be terminated and the EMD will be forfeited by the Gauhati High Court, Guwahati. The decision of the Registrar General regarding due performance of terms and condition of purchase shall be final.
8. Conditional tenders are liable to be rejected.
9. In the case of revision of Statutory Levies/Taxes during the finalization period of tender, the Gauhati High Court, Guwahati reserves the right to ask for reduction in the prices.
10. Prices once approved will remain valid during the scheduled delivery period. Increase and decrease of Taxes and other statutory duties will not affect the price during this period. The supplier will be responsible for any increase in Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of Rates shall be to the supplier's account.
11. The rates approved by the Registrar General, Gauhati High Court, Guwahati, shall be valid only for the period 2011-13.
12. Delivery of the martial to be made within one month by the supplier after releasing of the purchase order from the Gauhati High Court.
13. In case of failure of supply of the Material (Liveries) as per terms and conditions of the tender document or delays in supply, the Registrar General, Gauhati High Court, Guwahati reserves the right to allot the contract to the next

lowest bidder at the risk and cost of the first supplier, without any tender/quotation formalities, in addition to the imposition of the penalties.

14. Payments shall be made after satisfactory execution of the order and supply of material in satisfactory condition on bill basis. The decision of the Registrar General towards satisfaction of quality of material shall be final. Payment of the material supplied under purchase order will be paid on receipt of complete consignment and checking of the material and on production of following:

- a. Invoice in triplicate,
- b. Delivery Challan duly signed by the consignee.

15. Registrar General, Gauhati High Court, Guwahati reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.

16. Registrar General, Gauhati High Court, Guwahati is not bound to accept the lowest Tender.

17. Registrar General, Gauhati High Court, Guwahati reserves the right, to award the work to one or more bidders.

18. Registrar General Gauhati High Court, Guwahati reserves the right to terminate the purchase order at any time by giving an intimation in writing without assigning any reason.

19. In case of violation of terms and conditions of the tender document or unsatisfactory supply of material or of poor quality and below standard, Registrar General, Gauhati High Court, Guwahati reserves the right to terminate the supply order by giving intimation to the supplier/contractor and forfeit the EMD

The sealed quotations with the brand name of Mills together with a sample of cloth, at least 20cm, should reach the undersigned on or before **3 PM of 21st November, 2011** & no quotation/tender will be received thereafter.

20. The decision of the Registrar General in all respect shall be final and binding on all.
