GENERAL TERMS & CONDITIONS

1. A processing fee of Rs. 1000.00 (non-refundable) in the form of Bank Draft pledged to the Registrar General, Gauhati High Court, from any Nationalized / Scheduled Bank, shall be enclosed along with the quotation.
2. The sealed envelope containing quotation shall be marked as "*Quotation for Annual Maintenance Contract (AMC) of 14 (fourteen) numbers of Numeric make Online UPS*" and the following documents must be annexed with the quotation.
 - a) Copy of PAN Card.
 - b) Up to date copy of VAT Registration certificate.
 - c) Copy of Guwahati Municipal Corporation Trade licence.
 - d) An established showroom or shop of respective products.


Each page of the documents should be signed by the bidder with seal to establish the Bidder's eligibility and its qualification to perform the supply of materials if its bid is accepted. In the absence of any of the above documents / informations, the offer may be summarily rejected without making any further reference in this regard.

3. The rates approved by the Registry of the Gauhati High Court, Guwahati, shall be valid for the period of one year from the date of approval letter of this Registry. Increase and decrease of Prices, Taxes and other statutory duties will not affect the price during this period. The supplier will be responsible for any increase in Prices, Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of Rates shall be to the supplier's account.
4. Payments shall be made after satisfactory execution of the order on bill basis. The decision of the Registrar General towards satisfaction of quality of material shall be final.
