GENERAL TERMS & CONDITIONS:

REQUIREMENTS

1. The Gauhati High Court (Principal Seat) at Guwahati requires monthly comprehensive control of pest infestation in the New and Old Blocks, Chief Justice's Residence, Judges' bungalows and Judges' Guest House at Guwahati for a period of 3 (three) years.
2. Treatments are required in respect of Rodents, Mosquitoes, Termites, Cockroaches, Flies and Bugs etc.
3. The pest control should cover open area as well as hidden area like spaces under tables, chairs, almirahs, on and around the pile of files, wooden furniture, false ceiling, all staircases, lift lobby, on all toilet drain ducts, in all stores and for all practical terms, there should not be any space left unattended.
