- 3. Each page of the documents should be signed with full signature by the bidder with seal. In the absence of any of the above documents /information, the offer may be summarily rejected without making any further reference in this regard.
- 4. The bidder must provide the sample of the materials/ items, which he intends to supply. The sample after sale process is over will be returned. In the event, the supplied items do not match the sample provided; the material will be summarily rejected without any payment.
- 5. Delivery of the material to be made within 15 days by the supplier after releasing of the purchase order from the Gauhati High Court.
