## **NOTICE INVITING QUOTATION**

Dated Guwahati, the 5<sup>th</sup> Dec, 2015

Sealed quotation affixing Court fee stamps of Rs. 8.25/- only (Non refundable) are hereby invited from authorised dealers/suppliers for supply of Duracell Ultra Lithium Battery (6 volt.) to Gauhati High Court, Guwahati for the year 2015-16. The quotation should reach the Registrar General, Gauhati High Court, Guwahati on or before 11/12/2015 during working days.

### **GENERAL TERMS & CONDITIONS:**

- 12) Processing fee of Rs.1000/-(Rupees one thousand) only (Non refundable) in the form of Bankers Cheque/Bank Draft for each quotation separately in favour of Registrar General, Gauhati High Court, Guwahati from any nationalized/scheduled bank shall be enclosed along with the quotation payable at Guwahati.
- 13) Successful bidder has to deposit Rs.10,000/-(Rupees Ten thousand) only as security deposit in the form of bank guarantee in favour of Registrar General, Gauhati High Court, Guwahati.
- 14) The seal quotation shall be superscribed as "Quotation for supply of Duracell Ultra Battery (6 volt.)" and should contain the following documents:-
  - e) Copy of PAN card.
  - f) Upto date copy of AGST/VAT clearance certificate.
  - g) Copy of Gauhati Municipal Corporation Trade Licence.
  - h) Copy of AGST/VAT Registration certificate.
- 15) Rate should be quoted both in words and figure and excluding Taxes/VAT. Tax/VAT is to be shown separately against the item in the bills, where applicable, which will be deducted at source.
- 16) Rate quoted for each item will be final and no hike in price of any material will be considered during the contract period.
- 17) Sample of the items should be submitted where necessary.
- 18) The bidder shall quote rate against the specified brand name, size, weight etc. (where applicable) of the articles as per prescribed list/format appended herewith.
- 19) The articles will be purchase as per requirement and same shall be delivered to the Gauhati High Court wherever necessary immediately.
