7. TWO BID SYSTEM:-

All bidders required to submit their offers in two covers as under :

(a) FIRST COVER (Technical Bid) Should contain the following :-

- Tender documents all pages duly completed and signed BUT WITHOUT INDICATIONG THE RATES QUOTED
- II. Tender Cost (where applicable)
- III. Delivery terms, delivery period should be quoted separately.
- IV. Copy of trade license issued by State Govt/Union territory/CPWD/PWD.
- V. Performance statement of last three years.
- VI. Photo Copy of PAN/TAN No.
- VII. Tax or Income tax statement etc.
- VIII. Any other relevant documents which the firm wishes to submit.
 - IX. Technical compliance sheet
 - X. Escalation matrix for service of the items.
- XI. Certificate(s) from the OEM regarding authorization, quality assurance and service.

(b) SECOND COVER (Financial/Price Bid) should be contain the following:-

- i. Rate of the gadgets per unit.
- ii. Details of rate, taxes, duties, discounts, if any quoted by the bidder. These details should be submitted on their letter pad.
- iii. Rates must be clearly written in figures as well as in words.
- iv. There should not be any cutting/overwriting of figures/words.
- v. The rates should be valid till 31st March, 2024.
