**SHORT NOTICE INVITING TENDER**

1. Sealed tenders affixing court fee stamp of Rs.8.25 (Rupees eight and paisa twenty five) only with a validity period of 180 (one hundred and eighty) days is invited from the contractors registered under APWD (Building) for the following work:-

The Application / Quotations along with attested copies of the registration certificate (APWD), GST and PAN Card and minimum 3 numbers of completion certificates in respect of work executed at the High Court or District Courts must be submitted to the Office of the Joint Registrar (PM&P)/CPC, Gauhati High Court, Guwahati, by **16.02.2023, 4 P.M.** If for any reason the last date of receiving of Tender is declared as holiday, tender will be received and opened on the next working day at the same time mentioned above.
3. The prospective bidders may inspect the proposed worksite in any working day during office hours with prior intimation to the Joint Registrar (PM&P), before submission of the tender.
4. Bids must be accompanied by Bid security of the amount specified in the table above pledged in favour of the Registrar General, Gauhati High Court, payable at Guwahati. Bid Security will have to be deposited in the forms of Bank Draft/ Banker's Cheque/ FD along with the tender and shall have to be valid for 3 months beyond the validity of the bid.
5. Rates must be quoted both in figures & words legibly & clearly. If there is any discrepancy found between the rate in figure and rate in word, the rate in word will be considered.
6. The undersigned shall have the right of rejecting all or any of the tenders without assigning any reasons thereof and will also not be bound to accept the lowest tender.

7. The rates should be quoted considering all the taxes, duties and other levies as per Govt. rule and the same will be deducted from the bill as per prevailing rules.
8. The bidder will not be allowed to withdraw his bid after opening of the same and if he/ she desire so, his/her earnest money will be forfeited. If he / she wants to withdraw tender after submission and before opening, he may do so on written request to the undersigned.
9. For canvassing directly or indirectly will lead the bidder to disqualification including barring him from further participation in any bid or may even to blacklisting.
10. The SNIT will form a part of the Contract Agreement.
