- 3. The tenderers shall inspect the Diesel sets before submitting the tender and have to assess the probable cost of overhauling including the cost lubricants, air filter, diesel filter, coolant, belt, etc. and the Gauhati High Court shall supply only the diesel oil.

The successful tenderer will have to deposit EMD of ₹ 10,000.00 in the form of Term Deposit in favour of the Registrar General, Gauhati High Court, from any Nationalized Bank and the same will be kept for period of six(6) months and during the period of six(6) months for any defect in the generator set, the contractor will have to attend, in default, the EMD so deposited will be

forfeited.
