#### **Terms & Conditions**

- 2. The firm should have experience of executing at least one single work of similar nature and annual transaction of the firm with Govt. departments or any other organization should not be less than Rs. 1,00,000/- (Rupees One Lakh) only. A certificate from the competent authority should be attached along with the Bid.
- 3. The Bidder must submit copies of their GST registration certificate and PAN Card from competent authority.
