Earnest Money of ₹ 10,000.00 (Supees ten thousand) only should be submitted along with the quotation in the form of bank draft drawn in favour of Registrar General, Gauhati High Court, Guwahati, issued by any Nationalized/Scheduled Bank payable at Guwahati or unconditional Bank Guarantee valid upto during continuation of the contract.
- 3. The tenders in a sealed envelope addressed to the Registrar (General), Gauhati High Court, Principal Seat at Guwahati, duly marked as "Tender for Supply of wooden and steel furniture, LCD TV Sets, Refrigerators, etc." and the quotation should contain the following documents:

- a) Copy of PAN Card.
- b) Upto date copy of VAT clearance Certificate.
- c) Copy of Gauhati Municipal Corporation Trade Licence.

Each page of the documents should be signed by the bidder, with seal, on each page of each document, to establish the Bidder's eligibility to the bid & his qualification to perform the supply of material if his bid is accepted. - 7. In the event of any breach of any terms and conditions or delay in supply within the stipulated date or default, the order will be cancelled and the EMD will be forfeited.
- 8. Conditional tenders are liable to be rejected.
- 9. Prices once approved will remain valid during the scheduled delivery period. Increase and decrease of Taxes and other statutory duties will not affect the price during this period. The tenderer will be responsible for any increase in Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approved rates shall be the tenderer's liability.
