- 1. The sealed envelope containing quotation shall be marked as "*Tender for Supply of Compatible Cartridge and refilling of the existing cartridges*" and the following documents must be annexed with the quotation.
 - a) A processing fee of Rs. 1000.00 (non-refundable) in the form of Bank Draft in the name of the Registrar General, Gauhati High Court, from any Nationalized / Scheduled Bank
 - a) Copy of PAN Card.
 - b) Up to date copy of GST Registration certificate.
 - c) Up to date Copy of Guwahati Municipal Corporation Trade license.
- 2. Successful bidder has to deposit Rs.20,000.00 (Rupees Twenty Thousand) only as Security deposit in form of bank guarantee in favour of Registrar General, Gauhati High Court, Guwahati, issued by any Nationalized/Scheduled Bank payable at Guwahati.
- 3. Each page of the aforementioned documents should be signed by the bidder with seal to establish the Bidder's eligibility and its qualification to perform the supply of materials if its bid is accepted. In the absence of any of the above documents/ information, the offer may be summarily rejected without making any further reference in this regard. The Quotation shall also mention the firm's contact details clearly.
- 4. The rate approved by the Committee constituted for the selection of bidder, shall be valid for the said item/ items. The supplier will be responsible for any increase in Price, Taxes and Duties. Any increase in taxes and other statutory duties/levies

- after the approval of Rates shall be to the supplier's accounts. The bidder shall provide free delivery of the said items.
- 5. Payments shall be made after satisfactory execution of the order and supply of material in satisfactory condition on bill basis. The decision of the undersigned towards satisfaction of quality of material shall be final. Payment of the material supplied under purchase order will be paid on receipt of complete consignment and checking of the materials.
- 6. The undersigned reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.
- 7. The undersigned, is not bound to accept the lowest tender.
- 8. The undersigned, reserved the right, to award the work to one or more bidders. No communication shall be made in this regard except the selected firm/tenderer/bidder.
- 9. The undersigned, reserved to terminate the purchase order at any time by giving intimation in writing without assigning any reason.
