 - vi. Student & Law Students (till they enroll as lawyers);
 - vii. Members of Non-Political Service Oriented NGOs and Clubs;
 - viii. Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/vulnerable groups.
 - ix. Educated prisoners with good behaviour, serving long term sentences in prisons.
 - x. Any other person whom the District Legal Services Authority or Taluk Legal Services Committee deems fit to be identified as PLVs.
- 2. The last date for submission of applications will be on 20.03.2019 during office hours at the office of the Gauhati High Court Legal Services Committee at Guwhati.
- 3. The applicant's educational qualification should be HSLC or equivalent examination passed. He/she should have mind-set to assist the needy in society, and have the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society.
- 4. Applications received after the last date of submission due to postal delay or any other reason will be summarily rejected.
- 5. Eligible applicants will be selected for the post through mode of Personal Interview (Date to be Notified).
- 6. No TA/DA shall be paid to the applicants for attending the Personal Interview.
- 7. Incomplete application shall be rejected without assigning any reasons.
- 8. The work of PLVs doesn't carry any salary, remuneration or wage except honorarium fixed by the Assam State Legal Services Authority, Guwahati from time to time, as per rules.
- 9. Selected Para Legal Volunteers shall be required to undergo training programme as per decision of the Gauhati High Court Legal Services Committee.

- 10. The decisions of the Selection Committee in short listing the number of candidate for interview and selection of PLV shall be final. The eligible candidates shall have to appear for Interview before the Selection committee, the date of which will be notified in the official website.
- 11. In case of any objection regarding selection of PLVs, the decision of the Chairman, Gauhati High Court Legal Services Committee, Guwahati shall be final and binding on all concerned.
